No. E-1206, dated July 4, 2005 on aircraft modified per Solyo STC No. SA2353NM.

Limitations and Conditions: Approval of this change in type design applies to the above model aircraft only that are equipped with Solyo Turbine Pac (STC SA2353NM). This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated unless it is determined that the relationship between this change and any of those other previously approved modifications, including changes in type design, will introduce no adverse effect upon the airworthiness of that aircraft. A copy of this Certificate and the FAA approved Airplane Flight Manual Supplement (AFMS), Doc. No. E-1205, dated September 29, 2005 or AFMS, Doc. No. E-1207, dated September 29, 2005 must be maintained as part of the permanent records for the modified aircraft.
